So that the first question is whether this rule is valid. The authors of the Constitution believed that if an alleged criminal "acts as a witness," that is, if he is put on the stand to give his version of events, he may, if his testimony is material, be charged with perjury and, if he is convicted of perjury, he may be punished under the criminal law. So it has been held that even a person who is a sworn civil witness may be required to take the oath as a condition to the admission of his testimony. Sigler v. Cox (1913), 253 Pa. 559 (1917). In the case now before us, we are not dealing with testimony given in a civil or administrative proceeding, nor are we dealing with a witness who is being prosecuted for perjury or who is being summoned to testify against another as a result of a criminal investigation
